#### SECTION I: MDE UPDATES

#### 1. New Annotated Sample Items Book for M-Step Science

The <u>Spring 2018 M-STEP Science Annotated Sample Item Set</u> is now available on the M-STEP web page under What's New and Current Assessment Administration.

This M-STEP Science Assessment Annotated Sample Item Set offers details about the item clusters, student response types, correct responses, and related scoring considerations for the included sample item set. These items have been selected to show some of the new approaches being used to measure the Michigan K-12 Science Standards (MSS) adopted in 2015. All current item types included in the field test are represented, and additional samples will be provided over time. The sample item set covers:

- one item cluster and one mini item cluster in grade 5
- one item cluster in grade 8
- one item cluster in grade 11

The various item types are not limited to a particular grade level and could appear for any grade.

This is not a comprehensive sample test and does not represent all the standards that will be assessed on the Science M-STEP. Additionally, the examples within this document have been taken from the <a href="Online Tools Tutorial">Online Tools Tutorial</a> (OTT), which is openly available to the public.

# 2. <u>Early Literacy Resources</u>

To increase capacity for improving literacy in Michigan, the Essential Instructional Practices provide a small set of research-supported instructional practices as the focus of professional development for our state. The Office of Educator Excellence (OEE) has phased out the following endorsements effective **January 1**, **2018**, all MTTCs for these endorsements must be taken and passed prior to **July 1**, **2021** and will no longer be issued on certificates after **July 1**, **2026**.

# 6. <u>Health/PE Standards and Program Review</u>

The OEE hosted a technical assistance meeting to review Michigan's new Health and Physical Education (MC) teacher preparation standards and the application process for EPPs that wish to offer a new MC program. The timeline for the program review is as follows:

- Phase 1 Review (early adopters)
  - May 18, 2018: Program reviewer training
  - June 1, 2018: Program review materials due
  - June August 2018: Review program applications
  - Fall 2019: Start date for Phase 1 programs
- Phase 2 Review (regular adopters)
  - September 2019: Program reviewer training
  - November 1, 2019: Program review materials due
  - December 2019 February 2020: Review program applications
  - Fall 2020: State date for Phase 2 programs
- December 2020 Spring 2021: MTTC test, practice test and study guides debut
- Fall 2023: No new MA or MB endorsements will be issued

Each EPP submitting an application for review must nominate at least one individual to serve as a reviewer. # 7. <u>English as a Second Language/Bilingual Education Program</u> <u>Review</u>

New Michigan Standards for the Preparation of Teachers of English as a Second Language (ESL), and Bilingual Education were approved by the State Board of Education in February 2017. A program review technical assistance webinar was conducted in May, and is available for viewing online here. Program review applications for existing programs in these areas were due March 30, 2018. Each EPP submitting



applications for review must nominate at least one individual to serve as a reviewer. If you have not yet submitted a nomination, please submit nominations <u>online here</u>, and please ensure that reviewers know they are being nominated for this work. Reviewer orientation will be held via webinar on **May 4, 2018** from **1:00 PM to 2:30 PM**. The orientation will be recorded and shared.

# 8. Status of Administrative Rule Revisions

The Michigan Department of Education's (MDE) Office of Educator Excellence (OEE) is pleased to announce that the following newly revised Administrative Rules were filed with the Office of the Great Seal and became effective November 16, 2017.

- Teacher Certification Code
- School Administrator Certification Code
- School Psychologist Certification Code
- Certification and Licensure of School Counselors

# 9. <u>Certification Structure Update</u>

Superintendent Whiston has approved the concept of the <u>certification</u> <u>structure</u> revision with a request for communication and implementation plans and consideration for the unique staffing challenges of small schools. Superintendent Whiston has received letters from education organizations detailing the strengths and areas for consideration as the work moves forward and will be meeting a team from the OEE to discuss the next steps for a smooth transition. As a reminder, the purpose of the certification re-structure is to improve teacher quality by providing specialized preparation. Part of the implementation of the certification re-structure will include the re-examination of appropriate placement guidelines and permit flexibilities. We will be continuing to seek feedback on appropriate placement and permit flexibilities as the work moves forward.

# 10. Accreditation Updates CAEP updates

**New Initial-Level Program Handbook:** CAEP has released a revised Initial-Level Programs Handbook dated March 2018. The draft was shared on March 1 and feedback was due to CAEP by March 31. EPIs with site visits starting in Fall 2019 will need to use this handbook for their self-study reports.

**Annual Reports:** CAEP has also revised the template for the Annual Report(AR) due April 30, 2018. Please give yourself time to read through the directions and possibly gather additional data not previously requested for the AR. You can find a copy of the template HERE, the <u>Annual Report Technical Guide HERE</u>, and a webinar walking through the new <u>Annual Report HERE</u>.

**Advanced Programs:** In the process of negotiating a new CAEP state agreement, we will be operating under a Michigan-based definition of Advanced Programs that includes Administrator, School Counselor, School Psychologist, and Reading Specialist programs. Any additional endorsement will be considered an initial preparation program and should be aligned with the CAEP Initial-Level Program standards through the appropriate handbooks and guides.

#### 11. Special Education Programs

#### **MTTC Revisions**

MTTC special education assessments for Learning Disabilities (SM), Autism Spectrum Disorder (SV), Cognitive Impairment (SA), and Emotional Impairment (SE) will undergo review and revision over the next year. In addition, the MTTC for the combined Health/Physical Education endorsement will be developed over the next year. We are seeking volunteers with expertise in these fields to assist with this process which begins in July 2018. # **Special Education Program Review**

Requests for special education program did not go out in January as anticipated. These requests will be distributed in August to allow programs a full academic year to use data driven processes in

determining changes or revisions. If a program has not been reviewed for over 10 years, we will be requesting the submission of a full application for review. If you have been considering updating your special education program, use this time to revise your program's claims and assessments. Program revisions and new program applications will be accepted in November 2018 and April 2019. If you have special education teacher preparation programs you are no longer offering, now is the time to submit your closure documentation. Please submit those closure forms during the April 2018 or November 2018 windows.

# 12. Program Approval Windows

The fall program approval window closed on January 31, 2018. A spring application window opened April 1, 2018 and will remain open until April 30, 2018. After April 30, 2018, the application window will be open again in November.

#### 1. CPR/First Aid Update

According to the revised school code (380.1531d), candidates recommended for initial teaching certificates must hold a valid certification in the areas of first aid and cardiopulmonary resuscitation

# 7. Oral Proficiency Interview

All candidates for world language and bilingual education endorsements recommended must have achieved the appropriate level on the American Council on the Teaching of Foreign Language's (ACTFL) Oral Proficiency Interview (OPI) or Oral Proficiency Interview - Computer (OPIc). EPPs are responsible for verifying this achievement. The minimum levels specified in Michigan's teacher preparation standards are Advanced Low for all candidates for a Bilingual Education (Y) endorsement and for candidates seeking World Language endorsements in French (FA), German (FB), Italian (FH) and Spanish (FF), and Intermediate High for candidates seeking World Language endorsements in Arabic (FK), Chinese (FR), Greek (FC), Hebrew (FJ), and Japanese (FL). Providers may accept hand delivered verification of OPI/OPIc performance from candidates, although it is preferred candidates have OPI/OPIc score reports sent directly to the provider. You may request access to your candidates' scores directly from Language Testing International (LTI). Please contact Nicole Rome (nrome@languagetesting.com) at LTI to set up an account.

#### 8. <u>School Counselor Legislative Update</u>

HB 4181 passed and was signed by the Governor. It has an initial effective date of Feb. 6, 2018 with Feb. 6, 2020 as the date the law impacts professional development criteria used to renew any renewable school counselor credentials issued by the MDE.
