## **SECTION I: Legislative Updates**

Below is a selection of education-related bills currently before the Michigan Senate and House of Representatives. #### Voted out of committee, referred to House/Senate:

• SB 118 – Reduce salary deduction for noncertified teachers if district comes into compliance within 10 days of notification. Substitute bill waives deductions for 2020-21 academic year. *Passed the Senate, reported out of the House Education Committee with substitute bill, preparing for House vote 3/23/2021*

- SB 249 Substitute permit extension *Introduced 3/17/2021*
- Student Recovery Package: SB 56-57, 260-268. Replaces M-STEP with summative assessment selected by ISD request for proposal, eliminates student growth in educator evaluations, requires CEPI to collect teacher student data link, allows substitute teaching without credits for 20-21 school year, require reports to parents *Introduced 3/18/2021*
- HB 4548 Create school counselor corps grant program *Introduced 3/23/2021*
- SB 321 Mental health professional development standards *Introduced 3/26/2021*

**MEMO #013-21** – Encouraging Students To Fill Out FAFSA Forms (February 11, 2021) According to the U.S. Department of Education (USED), Michigan is experiencing a 14 percent decrease in Free Application for Federal Student Aid (FAFSA®) forms filed by high school seniors when compared to last year at the same time (see: <u>https://studentaid.gov/data-center/student/application-volume/fafsa-completion-high-</u> <u>school</u>), which mirrors a national trend.

**MEMO #027-21** – Critical Shortage List for Employment of Retirees (March 18, 2021) Pursuant to state statute (MCL 38.1361), the Michigan Department of Education (MDE) has compiled the list of critical shortage areas or disciplines for employment of retirees. **MEMO #028-21** – Children Matter. You Matter. Learn SEL. Launch (March 18, 2021) Social and emotional learning (SEL) is the bridge upon which all learning occurs. Reading social cues, identifying feelings, and working with a range of emotions are essential skills children need to navigate both the pandemic and the disruption with online and in-person learning. The skills of self-awareness, self-management, and social awareness enhance decision-making and teach a child how to connect with and befriend others. To that end, the Michigan Department of Education (MDE) is launching an effort to expand and strengthen SEL professional learning across the state.



#### MEMO #029-21 – Michigan Alternative Route to Interim Certification Programs

(March 25, 2021)

As part of the ongoing strategic efforts of the Michigan Department of Education (MDE) to increase the number of certified educators in critical shortage areas in Michigan and to diversify the workforce, MDE approves and maintains oversight of Michigan alternative route to interim teacher certification (MARITC) programs. The purpose of this memo is to inform local education agencies (LEAs), both traditional public school districts and public school academies (PSAs), about MARITC programs and interim teaching certificates (ITCs).

**MEMO #032-21** – Office of Auditor General Findings Related to Educator Evaluation, Mentoring, Induction and Professional Learning (*March 25, 2021*)

The Office of the Auditor General (OAG) conducted a performance audit of the work supported by the Michigan Department of Education's Office of Educator Excellence (OEE), for the period of 2015-2018. Audits by the auditor general are conducted in accordance with Article IV, Section 53 of the Michigan Constitution.

## SECTION III: Office of Educator Excellence Updates

#### 1. Ed Prep 101

OEE is developing a systematic approach to providing technical assistance for educator preparation programs. Broadly grouped under the title of Ed Prep 101, the goal is to support EPPs in onboarding new staff, introducing and updating program requirements, and addressing candidate concerns. Separate strands will be available for target audiences, at both traditional and alternate route providers, including teacher certification officers, program directors, accreditation coordinators, deans, advisors, faculty, and others. The project team is currently soliciting suggestions as to key materials and resources, and optimal delivery formats. #### 4. EPI Performance Management System

For this year, the Performance Score was calculated using the methodology in place since 2014. We are happy to announce that all EPIs were "Satisfactory"!



The proposal to revise Michigan's EPI Performance Score framework was presented to Dr. Rice in January. He approved the team to move forward with setting a threshold! The referent panel met the first week of March to determine the threshold and results will be reviewed by Dr. Rice in the coming weeks. Once the proposal is approved, MDE will send each EPI their results had the new methodology been used this year and hold a webinar to discuss the new methodology and its roll out.

As a reminder, the new methodology will take a phased approach to implementation to ensure new components are sound and accurate before being included within a score. Target initial implementation is 2021-22.

#### 7. MTTC Content Committee Volunteers Needed

Many MTTC fields are currently undergoing updates:

#### 8. MTTC: EI & CI Standard Setting

Standard setting is the "last call" for changes to a test. During standard setting, a panel of higher education faculty, early career educators, and educators experienced in supervising candidates during internship meet to determine the minimum passing criteria for an exam. They follow a research-based method involving several rounds of individual judgements which are ultimately used to recommend a raw cut score for an actual test form. No prior experience with standard setting, item review, or test development is necessary. We're most interested in people who know the needs of CI & EI teacher candidates.

#### 9. MTTC Bias Review Committee Volunteers Needed

Every bit of MTTC material (e.g., frameworks, items) is reviewed for potential sources of bias before going through a content review. While our partners at Evaluation Systems and your friendly OEE staff members try to catch potential bias before items go to committee, we rely on our bias review committee to ensure MTTC content is as equitable as accessible as possible.

Higher education faculty offer a perspective on teacher candidates and an awareness of bias that MDE values and needs represented on this committee. Committee members are not expected to provide content-specific knowledge to the group's work, and they are trained to identify potential sources of bias, so no formal experience is necessary.

#### 10. MTTC 5-Year Validity & Retesting

MDE recognizes MTTC test scores as valid for five years; however, on occasion there can be exceptions. Provided certain conditions are met (e.g., last change to teacher preparation standards, last change to test impacting test properties, willingness of EPI to recommend candidate for certification/endorsement), it is possible for a candidate to avoid retesting. #### 11. Paid Internships & Waiving Student Teaching

In August 2020, the Michigan Department of Education (MDE) released the memorandum "Supporting Hard-to-Fill Positions with Teaching Candidates." This memo to local and intermediate school district superintendents and to public school academy directors highlights the advantage that candidates enrolled in teacher preparation programs offer to schools over individuals with no training or teaching experience. As candidates need to complete clinical experience requirements throughout their program, including a final internship, MDE recognizes the potential for synergy that paid service can offer to PK-12 and teacher candidates. EPPs are also reminded that <u>R 390.1123(1)(b)(iv)</u> allows for waiver of the student teaching experience for individuals who have taught successfully for three to five years. MDE encourages educator preparation institutions to collaborate with local education agencies to support paraprofessionals, substitute teachers, and other non-certified personnel working in districts who wish to earn educator certification in an expedited manner. This provision of the Teacher Certification Code provides a flexibility to help with this process.

#### 12. <u>#PMEchat – The Knowledge Network of Proud Michigan Educators</u>

## **19.** Pilot with the Association for Advancing Quality Educator Preparation (AAQEP)

The Michigan Department of Education (MDE) has signed a pilot partnership agreement with the Association for Advancing Quality in Education Preparation (AAQEP) that recognizes and allows the use of AAQEP as an option to satisfy national accreditation obligations under R 390.1151(3) of the Teacher Certification Code. The goal of this pilot is to determine whether AAQEP's process satisfactorily meets MDE requirements for national accreditation.

The pilot program will be open to a limit of three educator preparation providers. Participants must currently hold full accreditation through the Council for the Accreditation of Educator Preparation and intend to utilize AAQEP for their next scheduled accreditation visit. Pilot program visits are to be completed by the end of the 2024-25 academic year. ## SECTION IV: Resources to Support Preparation Programs

#### 1. <u>\*NEW\* Michigan Virtual Online Module on Introduction to Social and</u> Emotional Learning

At the October 2, 2020 DARTEP meeting, MDE's Leisa Gallagher, Michigan Department of Health and Human Services's Lauren Kazee, and Eastern Michigan University's Wendy Burke delivered a presentation on Social-Emotional Learning (SEL) in Michigan. In March, MDE launched an '<u>Introduction to SEL</u>' online module hosted through Michigan Virtual. The hope is that as many educators as possible (a minimum of one school leader and two to four teachers per building across the state) will complete the module before Labor Day. The course is free, offers SCECHs, and takes about two hours to complete. This program is open to all interested educators at all levels, including pre-service teachers and educator preparation faculty. After the introductory course, there are four additional free courses in the Social-Emotional Learning series: Creating a Professional Culture Based on SEL, Embedding SEL Schoolwide, Integrating SEL into Culturally Responsive Classrooms, and Transitioning to Remote Teaching 6: SEL Supports.

#### 2. <u>\*NEW\*</u> East China Normal University Review of Education Special Issue: Beyond Well-being: Educating for Wholeness and Purpose

The importance of student well-being as a critical focus of schools and educational systems has taken on added urgency in the coronavirus pandemic. Schools around the globe have taken a wide range of approaches to supporting the well-being and flourishing of learners of all ages. In the <u>September 2020 special issue of the East China Normal University Review of Education</u>, an international group of scholars detail several of these approaches, providing much food for thought as Michigan schools respond to the needs of children and adults impacted by the pandemic. #### 3. \*NEW\* Parent Teacher Home Visits

Parent Teacher Home Visits (PTHV) is an evidence-based family engagement practice that is built on developing relationships of trust between families and educators via a unique home visit model. While the PTHV model is operational in 28 states (including MI) plus DC, PTHV has long believed that preparing pre-service educators in the PTHV model and the conceptual frameworks it is grounded in would go a long way toward creating stronger partnerships between families and schools. #### 4. <u>\*NEW\* REL Tool: Integrating Reading Foundations – A Tool for College</u> <u>Instructors of Pre-Service Teachers</u>

REL Southeast has developed a tool for college instructors of pre-service teachers to supplement the What Works Clearinghouse (WWC) practice guide <u>Foundational Skills to</u> <u>Support Reading for Understanding in Kindergarten Through 3rd Grade</u>.

The tool complements and extends the practice guide by providing lessons to assist college instructors in building pre-service teacher knowledge of evidence-based strategies



for helping students in kindergarten through grade 3 acquire the language and literacy skills to succeed academically.

Each lesson includes the following:

A recommendation reminder that provides a snapshot of the WWC practice guide recommendation and how-to steps for pre-service teachers. Guidance to support college instructors as they teach pre-service teachers about a specific skill, why it is important in learning to read, and how to support that skill in the classroom.

• Videos that explain foundational reading skills and demonstrate the use of activities intended to improve foundational reading skills among students in grades K–3. Pre-service teachers are asked to complete a video reflection worksheet for each video.

• Activities for pre-service teachers to complete with peers in the college setting that reinforce foundational skills taught to students in grades K-3.

#### 5. <u>\*NEW\*</u> Exploring the Impact of Student Teaching Apprenticeships on Student Achievement and Mentor Teachers

School districts often wonder whether hosting a student teacher negatively impacts student achievement or mentor teachers. The Journal of Research in Educational Effectiveness (JREE) has released Exploring the Impact of Student Teaching Apprenticeships on Student Achievement and Mentor Teachers (memberclicks.net) by Dan Goldhaber, John Krieg, & Roddy Theobald that indicates "little evidence that hosting a student teacher helps or hurts student achievement during the year of student teaching, at least in grades 4-8 in math and reading. However, in subsequent years we find modest positive impacts on student math and reading achievement of having supervised a student teacher." The important implication here is that hosting a student teacher can have a positive long-term impact on student achievement.
