SECTION I: Legislative Updates

Below is a selection of bills currently before the Michigan Senate and House of Representatives. This selection is limited to *educator workforce related bills* with activity since the <u>December 3, 2021 DARTEP update</u>.

Passed into law and signed by the Governor:

- PA 133 of 2021 \$10M allocation for teacher recruitment, training, development. *Effective 12/21/2021*
- PA 149 of 2021 Allow substitute teaching without college credits if an employee of the school. *Effective 12/27/2021 through 6/30/2022*

Active Bills

- HB 5685 Allow public schools to employ student teachers for up to a year without permit. *Introduced 1/25/2022*
- HB 5630 Require bullying professional development for teacher certification.
 Introduced 12/9/2021
- HB 5635 Eliminate college credit requirement for substitute teaching. *Introduced* 12/9/2021
- HB 4970 Seizure awareness professional development. *Passed House* 12/14/2021, heading to Senate Education and Career Readiness Committee


3. Administrator Program Revision Workshops

5. EPI Performance Management System

The 2022 EPI Performance Score will be released in March. As a reminder, the 2022 performance score will utilize the new methodology (<u>review video</u>). Additional data, including certification and employment data related to the performance management score calculation, will be released through a "data dump" in late winter 2022.

6. Paid Internships & Waiving Student Teaching

In August 2020, the Michigan Department of Education (MDE) released the memorandum <u>"Supporting Hard-to-Fill Positions with Teaching Candidates."</u> This memo to local and intermediate school district superintendents and to public school

academy directors highlights the advantage that candidates enrolled in teacher preparation programs offer to schools over individuals with no training or teaching experience. This memo is continually shared in OEE's <u>Superintendent's Workforce Guide</u>, released three times each academic year, to support efforts to grow the local educator workforce. The <u>Future Proud Michigan Educator Grow Your Own Programs School Personnel Grant</u>, previewed in the January issue of "Educationally Speaking" and announced in the press release above is explicitly designed to support school employees enrolled in teacher preparation coursework.

EPPs are also reminded that <u>R 390.1123(1)(b)(iv)</u> allows for waiver of the student teaching experience for individuals who have taught successfully for three to five years. MDE urges EPPs to collaborate with local education agencies to support paraprofessionals, substitute teachers, and other non-certified personnel working in districts who wish to earn educator certification in an expedited manner. This provision of the Teacher Certification Code provides a flexibility to help with this process.

7. MTTC: Lower Elementary (PK-3) & Upper Elementary (3-6) Pilot Testing

Juniors, seniors, and graduate students currently enrolled in Lower or Upper Elementary programs are invited to participate in pilot testing for these fields.

- Upper Elementary (3-6)
 - Registration opens in March
 - Pilot testing March 29 April 25

Pilot testing allows MDE to try out some test items before they go into the operational item bank, building the first test forms. Candidates take a shorter version of their grade band's test, with items from across all four subtests. They also provide written comments about items and the test overall.

Candidates can choose between a \$50 Amazon gift card or a \$75 MTTC test voucher.

8. MTTC: Lower Elementary & Upper Elementary Tests Operational in Fall 2022

MTTC tests for the Lower Elementary (PK-3) and Upper Elementary (3-6) tests are scheduled to be operational Fall 2022, with score reporting in late 2022 (Lower Elementary) and early 2023. This is a change from the previous goal of Spring 2022, which is due in large part to numerous challenges scheduling committees. 11. <u>Presidential Awards for Excellence in Mathematics and Science Teaching</u> (PAEMST)

The nomination window for the 2021-22 PAEMST award cycle (focusing on teachers of STEM subjects in grades K-6) closed on January 7, 2022, and now the work to assist applicants and review applications begins! Michigan relies on STEM content experts, particularly those educators working at our Ed Prep Programs, to assist the program by serving as mentors or reviewers. Mentors are needed to assist applicants prior to the application deadline of February 6, 2022, and reviewers are needed in February and March to

12. Program Application and Review: Grade Bands

The final submission window for the Lower Elementary and Upper Elementary was November 2021. This was also the first application window for Middle Grades and High School Professional, ELA and Mathematics. Applications submitted in November are currently under review by external review teams. Following that the Educator Prep internal review will commence, and feedback will be sent to programs by March 30. There will be 2-3 more submission windows for MG-HS Professional, ELA, and math: April 2022, November 2022, and if needed April 2023. 13. <u>Standards: Middle Grades (5-9) and High School (7-12) Science Teacher Preparation Standards</u>

The proposed Standards for the Preparation of Middle Grades and High School Teachers in Science will be presented to the State Board of Education for approval on February 8th. Watch for an announcement of the time and a link to the agenda.

14. Surveys

The fall/winter 2021 collection of the teacher candidate, cooperating teacher, and candidate supervisor surveys closes on February 13. Programs can review the list of respondents who have completed the survey on their <u>Qualtrics dashboard</u>. 15. Title II Reporting

The <u>Title II website</u> is back up! As a reminder, over the summer, the US Department of Education changed vendors and is now working with both <u>Trewon</u> and <u>RTI</u> to collect and manage the data. In terms of EPP interactions, RTI will manage the help desk. Notifications and communications will come from <u>Title2@rti.org</u>. The only timeline impacted by this vendor change has been the State Report Card, which was opened in mid-December and was due at the end of January. The report should be posted in February-March on the Title II website! 16. <u>Webinar Series: Preparing General Education Teachers to Support English Learners</u>

As mentioned in previous DARTEP meetings, OEE is collaborating with our colleagues in the Office of Educational Supports and a collaborative of representatives of ESL and Bilingual Education teacher preparation programs to develop a toolkit of resources to support general education teachers', teacher candidates', and teacher educators' understanding of effective practices for serving the needs of multilingual learners and their families. A piece of this toolkit is a webinar series focused on opportunities within the 5-9/7-12 Professional standards for enhancing teacher candidates' instructional practices with multilingual learners. The webinars highlight resources that can be utilized to integrate into general education courses to deepen pre-service teachers' understanding of how to better meet the needs of multilingual students in general education settings. 17. World Language Preparation Programs: Audit of OPI/OPIc Records

Since September 1, 2017, EPPs have been required to verify that all candidates for world language and bilingual education endorsements have achieved an Advanced Low (or Intermediate High for less frequently taught languages) on the Oral Proficiency Interview (OPI/OPIc) administered by Language Testing International (LTI). In December 2020, a comparison of certification records for world language/bilingual education endorsements issued since September 1, 2017 OPI/OPIc testing records available to MDE through LTI revealed 194 individuals who had been recommended for endorsements but for whom no OPI/OPIc records were available in the MDE database. OEE contacted each of the 26 EPPs that recommended these candidates in September 2021 to request OPI/OPIc results and testing dates. As of January 25, 2021, 24 EPPs responded to verify records of 163 individuals. In February, we will be sending letters to all 26 EPPs who were contacted in this audit to share individual program findings and request additional information as necessary. EPPs are reminded that starting in January 2022, the Michigan Online Educator Certification System (MOECS) will ask candidates to acknowledge they have achieved the requisite OPI/OPIc rating for a world language endorsement. EPP personnel approving applications will also be asked to acknowledge they have verified the candidate's OPI/OPIc rating. Incorrect information provided to this question in the application can be grounds for certificate suspension.



The timeline for implementation of the Early Childhood General and Special Education grade bands is as follows:

- First enrollment into B-K programs: Fall 2021
- B-K MTTCs projected to become operational: 2023
- Final offering of MTTC #106: 2026

5. <u>Grade Band Implementation Timeline: Lower Elementary (PK-3) and Upper Elementary (3-6)</u>

The timeline for implementation of the PK-3 and 3-6 grade bands is as follows:

- First enrollment into PK-3/3-6 programs: Fall 2021
- PK-3/3-6 MTTCs projected to become operational: Fall 2022
- Final offering of MTTC #103: July 2026

6. <u>Grade Band Implementation Timeline: Middle Level (5-9) and High School (7-12) English Language Arts, Mathematics, and Professional</u>

The timeline for implementation of the 5-9 and 7-12 grade bands for ELA, Math, and Professional is as follows:

- Program applications due: April 30, 2022, or November 30, 2022
- Program review: May 2022 September 2022, December 2022 March 2023
- First enrollment into programs: Fall 2023
- Professional, ELA, and Math MTTCs projected to become operational: 2024
- Final offering of MTTCs #085, 090, 002, 089 and 022: 2029
