SECTION I: Legislative Updates

Below is a selection of bills currently before the Michigan Senate and House of Representatives. This selection is limited to *educator workforce related bills* with activity since the February 4, 2022 DARTEP update.

- SB 942 Modify requirements for school counselor license reciprocity. *Introduced* 3/2/2022
- SB 941 Waive educator evaluation requirements for a specific eligible district for 2021-22. *Introduced 3/2/2022*.
- SB 726 Allow substitute teaching for retirees without reducing benefits after 4 months instead of 12. Reported out of committee, heading to Senate floor 3/16/2022.
- HB 5934-5937 Dyslexia: prescreening, advisory committee, teacher certification, preparation program approval. *Introduced 3/17/2022*.

- SB 969 Educator Evaluation: suspend requirement for 2021-22 academic year. *Introduced 3/17/2022.*

Governor Whitmer Education Budget Proposal Invests Heavily in Students and Teachers

Governor Gretchen Whitmer's PreK-12 budget proposes historic investments in school funding and would have a major impact on the shortage of teachers in Michigan public schools. "This budget would help advance every single goal of the state's Top 10 state strategic education plan and, in so doing, would improve the lives of our more than 1.4 million Michigan public school children," said Dr. Michael Rice, State Superintendent of Public Instruction.

The Governor's recommended budget marks the biggest state education funding increase in more than 20 years - without raising taxes, and includes provisions that would directly impact educators **in the next academic year**:

- \$1.6 billion for educator retention programs that make sure our educators have the supports they need and the recognition they deserve for the work they do, including:
- \$1.5 billion for payments to eligible teachers, administrators, and support staff who continue working in their school district over the next four years.
- \$75 million for innovative approaches to addressing regional educator retention needs.
- \$50 million annually for teacher onboarding and mentoring programs.
- \$600 million for educator recruitment programs to ensure the teacher talent pipeline continues to provide the education system with the best possible educators. Programs funded include:
 - scholarships for future educators,
 - stipends for student teachers,
 - training opportunities to create and improve school leaders.
 - o and expanded programs in school districts to recruit, train, and retain teachers from their communities.
- \$361 million for student mental health to ensure students with mental health needs can be identified and provided with the right support.
- \$66 million for school safety programs, building off existing school safety grant opportunities for districts and implementing cross-sector approaches to prevent mass violence through partnerships between schools, public safety, mental health professionals, and communities.

"There is increasing awareness of the enormous effect that the teacher shortage, exacerbated but not caused by the pandemic, has had on our public schools," Dr. Rice said. "Our needs are urgent, and we are encouraging the legislature to accelerate this funding through a

supplemental budget passed by the start of spring to give local school districts the time to begin to implement these efforts before the start of next school year."

The Governor's budget also recommends significant funding increases for pre-school and after-school programs, students with disabilities, students who are economically disadvantaged, English learners, and career and technical education.

The budget proposal now moves to the Senate and House of Representatives for review and amendment to eventually send to the Governor for her signature. This process takes time and includes several opportunities for public feedback.

5. Future PME EXPLORE Grants

The Future Proud Michigan Educator initiative will continue in 2022-23 with grants for EXPLORE programming aimed at students in grades 6-12. Here are the top 5 ways that you can support your district partners in applying for and using grant funds to create larger and more diverse teacher candidate populations:

- 1. Offer to help with the grant application. Collaborate as a writer or editor of the application, as district teachers and building leaders report feeling intimidated by the process.
- 2. Plan an on-campus event to offer in the 2022-23 academic year, which districts can pay for with grant funds. Ensure that your partners build this event into their budgets when they apply.
- 3. Review the Explore curriculum alignment map and standards to determine what aspects of the course can help candidates transition to your program. Work toward an MOU that can establish preferred admission, clinical placement hours, affinity groups, course credits, etc.
- 4. Serve on the grant-funded implementation team to guide the future educator effort in the school/district.
- 5. Encourage them to contact Holly Carruthers (<u>CarruthersH@Michigan.gov</u>), who will help support their Explore efforts.

6. MTTC: Lower Elementary (PK-3) & Upper Elementary (3-6) Standard Setting

Standard Setting conferences for the new elementary grade band tests are just around the corner:

- Lower Elementary (PK-3) August 8 August 12
- Upper Elementary (3-6) October 21 October 27

The purpose of the conference is for the committee of teachers and teacher educators to make a recommendation to MDE for the minimum passing score (aka "cut score") for each subtest in a given grade band. Please nominate your teachers and teacher educators for this exciting chance to provide direct input on what a just acceptably qualified candidate would know and be able to do. Specifically, MDE seeks volunteers who:

- are in their first 5 years of teaching, or
- are experienced teachers who have supervised student teachers (cooperating teachers) or early career teachers (mentors), or
- prepare future teachers in teacher preparation courses (higher ed faculty)

7. MTTC: Upper Elementary (3-6) Pilot Testing

Juniors, seniors, and graduate students currently enrolled in Upper Elementary programs are invited to participate in pilot testing for these fields. Registration is open now: https://home.pearsonvue.com/espilot/mttc. The pilot test runs through Monday, April 25. Pilot testing allows MDE to try out some test items before they go into the operational item bank, building the first test forms. Candidates take a shorter version of their grade band's test, with items from across all four subtests. They also provide written comments about items and the test overall. Candidates can choose between a \$50 Amazon gift card or a \$75 MTTC test voucher as a thank you for participating. 9. MTTC: Lower Elementary & Upper Elementary Tests Operational in Fall 2022

MTTC tests for the Lower Elementary (PK-3) and Upper Elementary (3-6) tests are scheduled to be operational Fall 2022, with score reporting in late 2022 (Lower Elementary) and early 2023. This is a change from the previous goal of Spring 2022, which is due in large part to numerous challenges scheduling committees. All 26 EPPs who were contacted in this audit received communication of individual program findings via email on March 18. EPPs required to provide follow-up information have until May 1 to submit that documentation to EducatorPrograms@Michigan.gov. All EPPs are reminded that starting in January 2022, the Michigan Online Educator Certification System (MOECS) will ask candidates to acknowledge they have achieved the requisite OPI/OPIc rating for a world language endorsement. EPP personnel approving applications will also be asked to acknowledge they have verified the candidate's OPI/OPIc rating. Incorrect information provided to this question in the application can be grounds for certificate suspension.


