SECTION I: Legislative Updates

Below is a selection of bills currently before the Michigan Senate and House of Representatives. This selection is limited to *educator workforce related bills* with activity since the April 8, 2022 DARTEP update.

- HB 6378 Create Future Educators Scholarship Program. Introduced 9/21/2022
- HB 6411 Relax substitute teaching requirements. *Introduced 9/22/2022*

Teacher Recruitment a Major Highlight in State School Aid Budget

The Michigan Legislature allocated an unprecedented \$555 million dollars to support the educator workforce in fiscal year 2023, including:

• \$175 million for Future Proud Michigan Educator Staff programs to support school employees who desire to earn teacher certification and Future Proud Michigan Educator EXPLORE programs to provide students in grades 6 to 12 the opportunity to experience careers in education.

- \$355 million for Future Educator Fellowships and Student Teacher Stipends. These
 funds will be disbursed by the Department of Treasury. The Michigan Department
 of Education will share information about these opportunities via the Future Proud
 Michigan Educator webpage as it becomes available.
- \$15 million for Future Proud Michigan Educator Veterans. This program provides a method for districts to offer a paid mentorship and salary for military veterans seeking educator certification.
- \$10 million to ISDs to recruit and hire career and technical education (CTE) educators.

1. 2021-22 MDE Annual Report

Notes from Fall CAEPCon:

- 1. CAEP is further refining definitions of "completers" to include two variations.
 - a. Program Completers for Annual Reports are anyone who completed a program
 - b. Program Completers for Standard 4 should be those who completed a program, achieved certification/endorsement, AND are working in a position for which you prepared them. Those should be the individuals you collect standard 4 data from and invite to your site visits.
- 2. NASP! CAEP reminded us that if a school psychologist program would like to use NASP as their accreditor, they must complete an accreditation visit prior to the CAEP visit. A SPA recognition report is not the same as an accreditation report and visit. Please check with your school psychologist programs to determine when they intend to submit for NASP accreditation.

5. Administrator Program Revision Workshops

We continue to hold Administrator Program Revision Workshops monthly throughout the program revision period. The next three workshops are on

6. EPI Performance Management System

OEE continues to collect data for the 2023 EPI Performance Score. Providers were given a preliminary preview of their scoring for indicators derived from the 2021-22 survey data. Additional data to be incorporated include MTTC cumulative pass rate data and educator effectiveness ratings.

To gather additional candidate placement data beyond the surveys, OEE has circulated a template for EPIs to provide additional placement data for candidates who had a placement other than at a Michigan public school. 7. ESL Endorsements Transition to PK-12: Applications Due June 30, 2023

All current English as a Second Language (NS) endorsement programs are scheduled to submit full approval applications in June 2023. We have generated valuable input from EPPs through a survey distributed in June and ongoing conversations. This input informs updates and enhancements to the current NS teacher preparation standards. While the standards are not being revised, additional guidelines will be added to the standards to support EPPs in transitioning programs to encompass the full PK-12

grade span. It is great to learn of various EPPs' proactive program analysis and realignment to MDE's 2017 NS standards prompted by what redesigns to pathways, courses and/or clinical experiences that came about from the new grade level bands programs.

Continued dialogue with EPP stakeholders is planned for at the upcoming IHE EL Collaborative to inform revised guidelines for PK-12 NS endorsement programs. 8. Future PME EXPLORE Grants

The Future Proud Michigan Educator initiative will continue in 2022-23 with grants for <u>EXPLORE</u> programming aimed at students in grades 6-12. Here are the top 5 ways that you can support your district partners in applying for and using grant funds to create larger and more diverse teacher candidate populations:

- 1. Offer to help with the grant application. Collaborate as a writer or editor of the application, as district teachers and building leaders report feeling intimidated by the process.
- 2. Plan an on-campus event to offer in the 2022-23 academic year, which districts can pay for with grant funds. Ensure that your partners build this event into their budgets when they apply.
- 3. Review the EXPLORE curriculum alignment map and standards to determine what aspects of the course can help candidates transition to your program. Work toward an MOU that can establish preferred admission, clinical placement hours, affinity groups, course credits, etc.
- 4. Serve on the grant-funded implementation team to guide the future educator effort in the school/district.
- 5. Encourage them to contact Holly Carruthers (<u>CarruthersH@Michigan.gov</u>), who will help support their EXPLORE efforts.

9. Grow Your Own Grants

Based on the success of previous Future Proud Michigan Educator (Future PME) grants and additional funding appropriated by the governor and legislature, the Michigan Department of Education (MDE) is excited to announce new grant opportunities for Future PME Grow Your Own (GYO) programming.

GYO Staff program grants are intended to support partnerships between PK-12 schools and educator preparation providers for pathways for school support staff to earn initial teacher certification or for certified teachers to earn additional endorsements via advanced degrees. Grants may be used to reimburse tuition and fees at an approved Michigan educator preparation provider. Books, testing fees, travel for coursework, and substitute employee wages may also qualify, based on the program design.

Applicants are expected to submit a memorandum of understanding between partners (K-12 and EPI) that details requirements that will support a high quality program.

10. MOECS: Temporary Shut Down

The Michigan Online Educator Certification System (MOECS) will be down for server migration beginning Thursday, October 13 and will be back up and running again on Tuesday, October 18. Not only does this stop the education community from using MOECS, but it also stops OEE's helpdesk from being able to process or upload anything. OEE will not have access either... No MOECS for anyone!

Phone support (517-241-5000) will remain open during this time for districts and educators to ask questions even if they cannot use MOECS. Our team can continue to support general questions about renewals, placement, or other certification needs. Callers will need to know all of the pertinent information regarding their situation as we will not be able to look anyone up. Please be patient with us (and spread the word!) as it will lead to an increase in calls about MOECS not working.

11. <u>MTTC: Upper Elementary (3-6) Standard Setting & Bilingual Education Standard Setting</u>

Standard Setting conferences for the new Upper Elementary (3-6) subtests and Bilingual Education are just around the corner:

- Upper Elementary (3-6): Professional & Literacy: October 24 October 25
- Upper Elementary (3-6): Math & Science/Social Studies: October 26 October 27
- Bilingual Education: October 24 October 25

The purpose of the conference is for the committee of teachers and teacher educators to make a recommendation to MDE for the minimum passing score (aka "cut score") for each subtest or test. Please nominate your teachers and teacher educators for this exciting chance to provide direct input on what a just acceptably qualified candidate would know and be able to do. Specifically, MDE seeks volunteers who:

- are in their first 5 years of teaching, or
- are experienced teachers who have supervised student teachers (cooperating teachers) or early career teachers (mentors), or
- prepare future teachers in teacher preparation courses (higher ed faculty)

13. Program Application and Review: Grade Bands

The November 2022 Application window will close on November 30. EPIs are invited to submit applications for English Language Arts, Mathematics, Science, and Professional Knowledge and Skills for the middle grades (5-9) and high school (7-12) grade bands. Information and links to the application survey will be sent via email in mid-October. If you are expecting to apply and do not get the information and survey link, please let us know. Applications submitted in April should have received preliminary feedback by the end of August. There are two remaining submission windows for MG-HS Professional, ELA, and Math: November 2022, and if needed April 2023. Science will be accepted through April 2024. 15. School Counselor Credential Name Changes

School counselor credentials issued by the Office of Educator Excellence (OEE) of MDE recently received a name change added to the <u>Administrative Rules that Govern the Certification and Licensure of School Counselors</u>. Please update your institution records to reflect the following name changes for in-state candidates eligible to be issued the following school counselor certifications.

The credential exclusively issued to in-state applicants, and previously known as the Preliminary Employment Authorization to Work as a School Counselor (PEASC), has been renamed the Preliminary School Counselor Credential (PSCC).

The credential issued for in/out-of-state applicants, formerly referred to as the School Counselor Guidance License, is now the School Counselor License (SCL).

As an FYI, candidates who have completed all requirements of an out-of-state approved school counselor education program were previously issued the Temporary School Counselor Authorization (TSCA) prior to completing the School Counselor licensure test (MTTC #51). The TSCA has been renamed as the Temporary School Counselor License (TSCL). 16. Surveys

Rostering for the fall/winter 2022 Candidate Suite Surveys (i.e., the teacher candidate, cooperating teacher, and candidate supervisor surveys) will begin on **October 12**. Survey links will be distributed by November 16 and the survey will remain open through February 3, 2023.

At the DARTEP meeting, MDE will discuss upcoming changes to the rostering process. To facilitate the new grants being awarded to student teachers, MDE and the Department of Treasury will require additional information including placement district and school along with which placement this is (e.g., special education, general education). Further details will be announced during the meeting.

As a reminder, providers can review the list of respondents who have completed a survey on their Qualtrics dashboard. MDE encourages programs to reach out and remind missing respondents to complete the survey by the deadline as response rate is now included within the performance score.
