



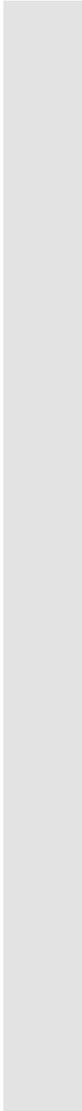






Port Authority Fairway

Program Closure Documentation

- Two documents required:
 - Report of Program Closure
 - Program Closure Roster
- Due 6 months from new program approval
- Important for accuracy of ProPrep & MOECS
- Rosters may be updated as necessary

Legislative Updates

- Legislature has adjourned for the rest of the calendar year and will resume in January
- SB 395 & 396 - Educator evaluation - signed by Gov (PA 224 & 225, effective 7/1/24)
- HB 4752 - Retiree employment - signed into law - [Office of Retirement Services](#) is responsible for implementation

MI Fellowship Program Process Requirements:

- Once a student is initially determined eligible, the institution must certify the student is meeting the program requirements. Once this is confirmed, a Commitment to Teach in Michigan Agreement is sent to the student.
- After a student signs their agreement, the institution must request a payment from Treasury.
- NOTE: 2023-24 Application opened May 1, 2023: 3,409 applications received; 2,492 eligible (see next slide for details).

MI Stipend Program Process Requirements:

- The institution must certify a payment record for each student to receive a payment from Treasury.
- Students may be certified by their institution as “No” for not meeting program requirements. Students may be certified by their institution as “No” for one semester and paid in another semester. This will create duplicate counts for categories processed by semester and may be great than or equal to the Total Eligible Student count.
- MDE reported 2,033 student teachers to Treasury for 2022-23.
- NOTE: 2023-24 Fall application opened May 1, 2023: 2,326 received; 2,155 eligible (see next slide for details).



MI Fellowship: ~73.1% eligible for MI Fellowship in 23-24 compared to ~25.2% eligible in 22-23.

MI Stipend: ~92.6% eligible for MI Stipend in 23-24 compared to ~75.3% eligible in 22-23.

MTTC Data: LE & UE Pass Rates, Subarea Means

- LE & UE tests launched summer/fall 2022
- Each test has 4 subtests: Professional, Literacy, Math, Science/Social Studies
- Candidates must pass 4 subtests for an endorsement
- No “mix and match” (except for Professional)
- Candidates do not “pass” subareas

MTTC Data: LE & UE Pass Rates, Subarea Means

Things MDE noticed:

- Many more LE candidates than UE
- Literacy is tough for candidates
- Literacy subarea 002 is low for LE and UE
- Test objectives for Literacy subarea 002 contains most foundational literacy skills (print concepts, PA/phonics, spelling/handwriting)
- UE Math subarea 003 is lower than 001 and 002


