Legislative Updates

Science of Reading/Dyslexia

A package of bills (SB 567/568) will be heard by the Senate education committee on January 30. MDE supports the concept, and we look forward to working with the legislature to ensure that the bills can be implemented appropriately if passed. OEE was asked to provide representation at the committee hearing to answer any questions about our suggested improvements.

• 2024-2025 Budget

Governor Whitmer has announced that her Executive Recommendation for the next fiscal year budget will be presented to legislative committees on February 7. This will kickoff the cycle and ramp up our related work.

Data & Accountability Updates

CPAST Updates

- → Five EPIs piloted CPAST during the fall
- → Surveyed all participants about their experience with the tool



CPAST Survey Quick Summary

Majority of the responses were positive across response groups

CPAST's consensus meetings are valuable

- 84% of candidates felt they received thorough feedback as a result of the consensus process
- 86% of teachers/supervisors agreed that the feedback provided to candidates was more thorough than other tools

Over 53% of teachers and supervisors prefer using the CPAST moving forward; another 37% are indifferent to the tool utilized by the EPP






