Legislative Updates

- **Science of Reading/Dyslexia (SB 567 & 568)**

Passed by the Senate, March 12; referred to House Education

- **2024-2025 Budget**

Executive, House, and Senate budget bills have been released

- **“National” Tests (SB 354)**

Senate Education Committee testimony, April 30

- **School Libraries & Librarians (SB 741, 742, & 743)**

Referred to Senate Education Committee, March 6

(School Librarian Preparation Standards to SBE, June 11)

Educator Evaluation Changes (PA 224 of 2023)

- What are the changes?
 - Removes ratings as requirement for certificate progression
 - Changes rating categories to **effective**, **developing**, and **needing support**
 - Updates exemption options for biennial and triennial evaluations
 - Effective July 1, 2024
- How does this affect you?
 - Update information provided to program completers about what to expect in the field

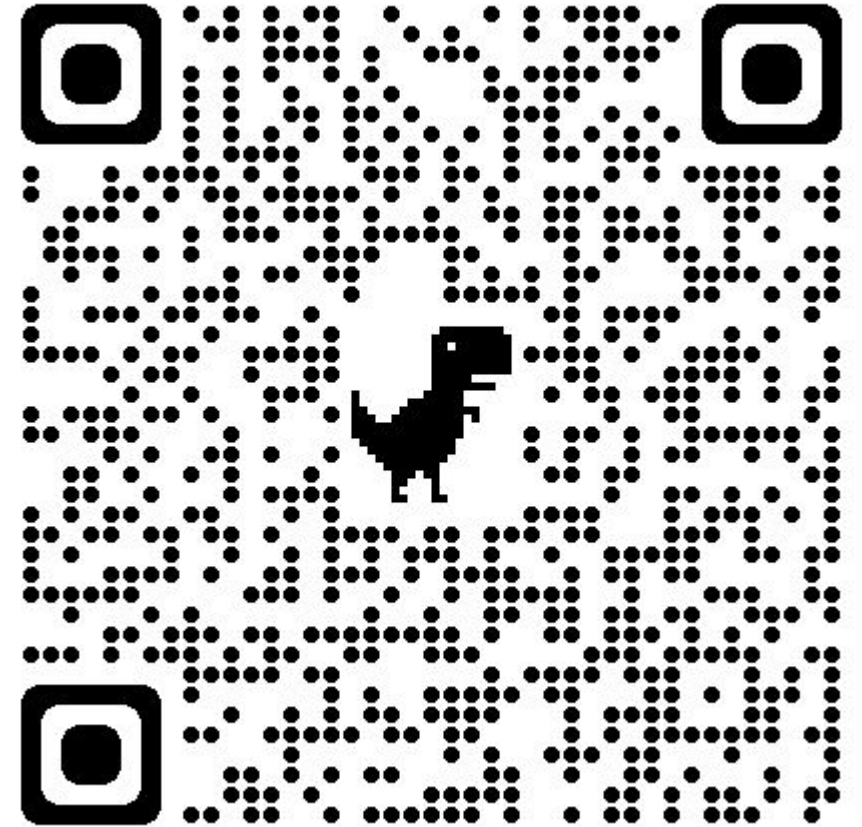
Accountability Updates

- In Progress Metrics Updates:
 - Clinical Observation: CFAST Pilot
 - Candidate/Completer data



Data Dashboard

- Updated with 2022-23 data
- New metrics:
 - Top 10
 - Surveys
 - Retention



PEARSON Right Start

- *In development* Pearson-created tool to support candidates preparing for licensure tests (MDE considering LE & UE)
- Self-paced, study plans based on diagnostic feedback
 - diagnostic test
 - content modules & practice questions
 - practice test
- Dashboards to easily track progress
- Subscription model (30 days, 90 days)

MTTC: Administrator Tests

- ES (MI139) and CO (MI140) endorsements
- Registration open, testing begins 5/13
- MDE providing vouchers to cover test fees
- Phasing in “passing” criteria:
 - Good Faith Effort
 - Panel-Recommended Cutscore
- “Ready to recommend” candidates should apply as soon as ready to avoid MOECS test requirement check

MTTC: More New Tests!

- Expanding into HS & MG
 - HS Math
 - HS ELA
 - HS Professional
 - MG Professional
- Registration open, testing begins 7/8 (Math & ELA) and 6/10 (Professional)
- MDE's Professional Testing Policy will be updated to reflect:
 - additional HS/MG examples
 - PK-12 (for initial certification)

MTTC: Test Center Experiences

- Was your candidate...
 - given a calculator when they shouldn't have?
 - given incorrect or difficult test center directions?
 - allowed to leave their seat without alerting anyone?
 - not receive a locker for their items?
 - get distracted because test center staff were making noise (on the phone, having unrelated conversations)?
 - told "that's how it's supposed to happen, but we do things differently here" when they asked a question/noticed something odd?
 - generally unhappy with their test experience?

MI Fellowship Program Process Requirements:

- Once a student is initially determined eligible, the institution must certify the student is meeting the program requirements. Once this is confirmed, a Commitment to Teach in Michigan Agreement is sent to the student.
- After a student signs their agreement, the institution must request a payment from MI Student Aid.
- NOTE: 2023-24 Application opened May 1, 2023: 4,431 applications received; 3,104 eligible (see next slide for details).

MI Stipend Program Process Requirements:

- The institution must certify a payment record for each student to receive a payment from MI Student Aid.
- Students may be certified by their institution as “No” for not meeting program requirements. Students may be certified by their institution as “No” for one semester and paid in another semester. This will create duplicate counts for categories processed by semester and may be greater than or equal to the Total Eligible Student count.
- MDE reported 2,033 student teachers to MI Student Aid for 2022-23.
- NOTE: 2023-24 Fall application opened May 1, 2023: 3,059 received; 2,839 eligible (see next slide for details).

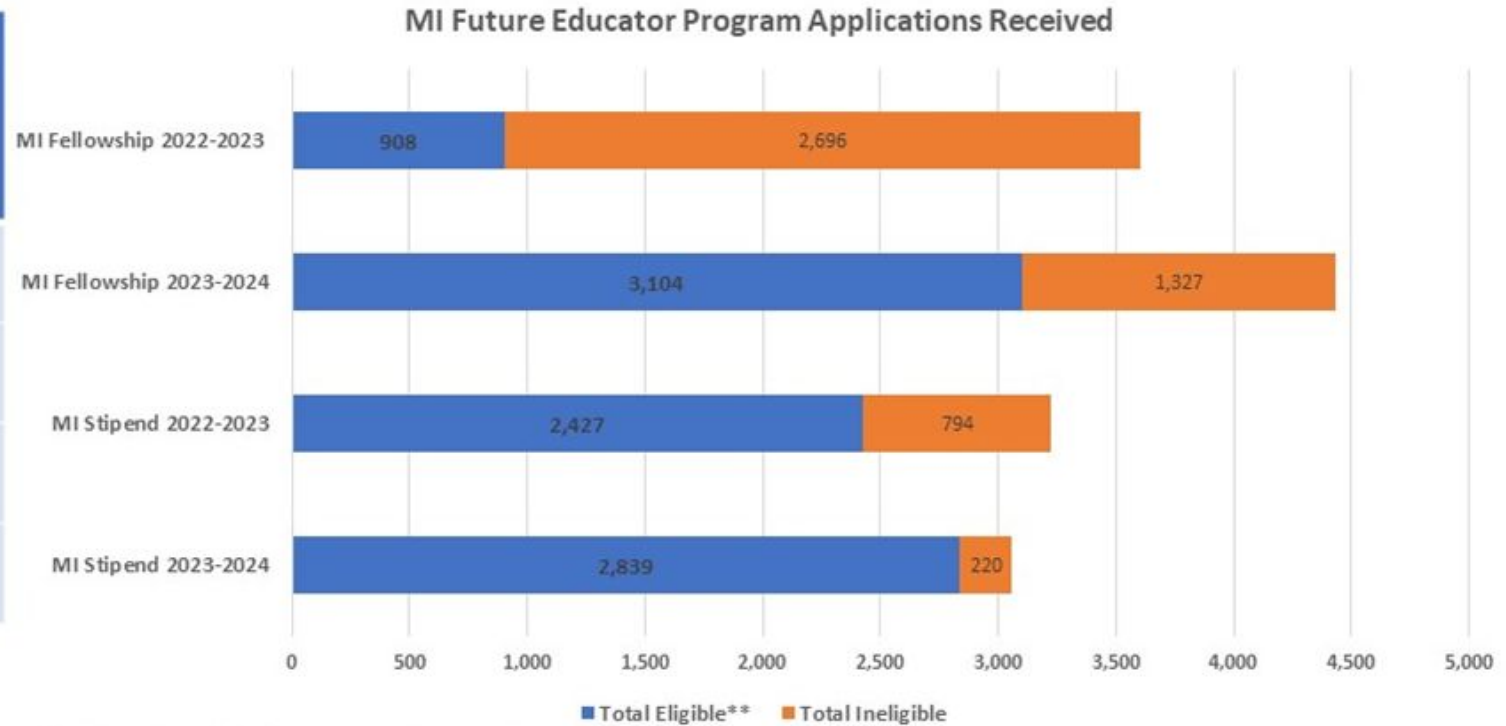

MI Fellowship 2023-2024	4,431	3,104	1,327
MI Stipend 2022-2023	3,221	2,427	794
MI Stipend 2023-2024	3,059	2,839	220



MI Fellowship: ~70.1% eligible for MI Fellowship to-date in 23-24, compared to ~25.2% eligible in 22-23.

MI Stipend: ~92.8% eligible for MI Stipend to-date in 23-24, compared to ~75.3% eligible in 22-23.
