## SECTION I: Legislative Updates

Legislative Updates Below is a selection of bills currently (as of April 25, 2024) before the Michigan Senate and the House of Representative. This selection is limited to educator workforce related bills with activity since the February 2, 2024 DARTEP update. Details about the status of all bills currently before the legislature, including full text and analysis (where available) may be found at <a href="http://legislature.mi.gov">http://legislature.mi.gov</a>. #### Fiscal Year 2025 Budget

The fiscal year 2025 budget negotiation process is underway in anticipation of the July 1 target. The legislature hopes to have bills on the House and Senate floors by May 3. Individual budget bills are likely to move through the chambers, with the final product of two budget bills: an omnibus bill for state agency budgets and a State School Aid budget.

SB 744 – Teachers and administrators; requirements for a teacher to successfully complete a probationary period. Passed Senate. Referred to House Education Committee. 3/19/2024

A report and summary of public comment is scheduled to go to the Joint Committee on Administrative Rules (JCAR) by April 30 and requires that the committee hold session for 15 days in order to provide feedback. OEE anticipates this will occur during the month of May. If all goes well, these Rules could go into effect by July 1. Procedures changes will be implemented as soon as possible. However, updates to





MOECS may require time to implement. Stay tuned for formal communications regarding specific aspects that may impact your work!

#### <u>CPAST</u>

Five EPPs piloted the CPAST observation tool during the 2023-24 academic year. MDE and pilot participants are presenting about their experiences and observations with the tool during the Michigan Continuous Improvement Conference.

Additional EPIs have volunteered to pilot the tool for 2024-25. During this time, the group will continue to collect data before MDE makes decisions about whether and how to include the tool in the annual performance score.

#### • Disciplinary Literacy Preparation Standards 2024, APPROVED!

A dedicated group of the standards development committee and additional preparation faculty volunteers have been collaborating on implementation resources and supports documents, which will join our library of <u>Preparation Standards Implementation Resources</u> upon publication. #### Educator Workforce Data Report

#### • EPI Performance Management System: FEEDBACK OPPORTUNITY!

The 2024 EPI Performance Scores were distributed in February.

One indicator that still needs to be incorporated into the annual score is *Candidate Selection and Completion*. This indicator will track cohorts of candidates and examine completion rates overall as well as across demographic categories.

A critical piece of collecting these data is to support efforts to reduce burden on our EPPs in CAEP and Title II reporting. With this in mind, OEE held focus groups on best processes in 2021 and has been working toward enhances to MOECS based upon the feedback received.

OEE will be hosting sessions for EPPs in late May and early June to review the MOECS processes and consider release planning. If you wish to participate, please register via this availability link.

#### Grow Your Own (GYO) Staff Grants

Sec. 27b GYO grant: The GYO Team has had some very positive responses from the Office of Educational Supports and the Office of Partnership Districts as we contemplate an extra level of team-based customer service to assist districts with schools indexed for support with their forthcoming applications for the remaining 27b grant monies. We've got about \$44 million left to award and we want to do everything we can to see these districts make successful and complete applications on GEMS/MARS, which will be open for this group, as well as for previous grantees, on or around Friday, April 19.

Sec. 504 EXPLORE grant: Application reviews are underway, with an estimated award announcement in the first week of June.

#### Mentoring and Induction

The application for the 27h(5) Mentoring Standards, Curricula, and Professional Learning Grant has closed and the review process has begun. Award notifications will be sent in mid to late May with work starting in June.

The application for the 27h(6) Mentoring Program Evaluation Grant is under development. The grant application is expected to open in late May or early June. The purpose of this grant is to award \$500,000 to a qualified evaluation entity to evaluate mentoring and induction programming in Michigan, including providing recommendations to improve programming. Eligible applicants are qualified evaluation entities that can demonstrate prior success in program evaluation, including data collection and analysis using both qualitative and quantitative methods; capacity to conduct statewide program evaluation, meet deadlines, and complete deliverables; and prior knowledge in Michigan's education system, new educator mentoring, and/or educator induction practices.



# **MI FELLOWSHIP AND MI STIPEND METRICS**



MI Fellowship: ~70.0% eligible for MI Fellowship to-date in 23-24, compared to ~25.2% eligible in 22-23. MI Stipend: ~93.0% eligible for MI Stipend to-date in 23-24, compared to ~75.3% eligible in 22-23.

#### MTTC: New Tests – Administrator (ES & CO Endorsements)

MDE is proud to launch new tests for the current Elementary & Secondary School Administrator (ES) and Central Office Administrator (CO) endorsements. More details will be sent to the DARTEP listserv, but highlights include:

- Registration opened 4/23 0
- Testing begins 5/13





- MDE will provide test vouchers to EPPs with the goal of covering test fees for the first cohort (more to come separately)
- Passing criteria will be phased in:
  - beginning with a "good faith effort" to meet minimum requirements, and
  - progressing to panel-recommended cutscores in May 2025 (as per usual MDE policy)

EPPs can look for information about vouchers coming soon, with timelines and other testing FAQ available shortly after.

#### • MTTC: New Tests – HS Math, HS ELA, HS Professional, MG Professional

MDE is also proud to launch the first High School (7-12) and Middle Grades (5-9) grade-banded tests, expanding the certification structure to secondary levels.

- Tests include:
  - High School (7-12) Mathematics
  - High School (7-12) ELA
  - High School (7-12) Professional Knowledge and Skills
  - Middle Grades (5-9) Professional Knowledge and Skills
- Registration for all four tests is now open
- Testing for HS ELA and HS Math begins 7/8
- Testing for HS and MG Professional Knowledge and Skills begins 6/10

With Professional Knowledge and Skills testing for all four grade bands opening, MDE will update guidance on testing for these subareas, including requirements for candidates pursuing PK-12 endorsements (e.g., Health and Physical Education, Spanish, Music Education) on initial certificates.

#### • MTTC: Test Center Experiences

Did your candidate have an unusual test center experience? Tell MDE! We want to work with Pearson VUE to ensure that every MTTC candidate gets the level of service and quality that they've paid for and are entitled to, but we can only improve what we know about.

If you have a candidate who had a problem, please have them contact MDE with:

- test center location, date, approximate time of day
- brief description of what happened

If your candidate prefers to remain anonymous, please send what they're comfortable sharing through a representative of your EPI. Please note that, at a minimum, we need the test center location and a brief description of what happened.

#### • MTTC: Expiring Scores for Old Programs & Candidate Outreach





As part of program closure, EPPs should reach out to candidates who completed program requirements and passed the relevant MTTC but have not yet applied for their credential in MOECS.

As described in MDE's <u>MTTC Five-Year Validity and Retesting Policy</u>, candidates whose scores are more than five years old for any of the above tests *will need to retest* (see scenario 2 in the policy) because a significant change has occurred with their content area exam. To minimize the number of candidates who need to retest with the new exam, EPPs should identify candidates who completed program requirements and passed the old MTTC within the last 5 years and strongly encourage them to apply for their endorsement in MOECS. Candidates who try to apply with scores older than 5 years for these fields will not be allowed to use expired scores toward their endorsement.

\*ZS and ZG are included in the table as a reminder that these programs are currently phasing out and exams will end soon. Because the associated tests have not *yet* ended, candidates for these fields do not *yet* face the same urgency as others noted in this section; however, these programs are typically larger for many EPPs. As such, EPPs should begin outreach to candidates who have not yet applied for their endorsement to avoid a significant spike in outreach later. EPPs should also consider processes and timelines to communicate with candidates in sunsetting secondary programs, such as English or Mathematics.

#### <u>MTTC: Higher Education Representatives Needed for Reviews</u>

MTTC content depends on input from early career teachers, experienced teachers who have supervised student teachers, and higher education representatives who prepare teacher candidates. Committee members are eligible to receive SCECH credits, a stipend from MDE, and substitute reimbursement (paid to the district), as well as travel accommodations for in-person meetings. The following committees will need input from higher education representatives in the coming months (some exact dates are TBD; all meetings are virtual unless noted with \*):

All committee members are eligible to receive:

- SCECH credits (8 credits per planned day of work)
- Paid stipend (\$75 for up to 1 full day of planned work, \$150 for meetings planned to exceed 1 full day of work)
- Substitute reimbursement, paid directly to a school/district
- Higher education representatives will receive a voucher code for a practice test (see next item!)

#### • MTTC: Higher Education Representatives Receive Practice Test Access

As an additional incentive to volunteer, higher education representatives who serve on MTTC committees will receive access to a full-length practice test of their choice. Following the committee meeting, Pearson will distribute a voucher code to higher education representatives. Higher education representatives will receive a voucher code **every time** they serve. The voucher code can be used to purchase a full-length practice test for any area, and codes can be given to others.





Due to the nature of the test development schedule, the practice test for a given field is available when registration for the field opens, usually 1-2 months before the first available test appointment. There will be a delay between serving on a Content Advisory Committee for a test field and being able to apply the voucher code for that test field. Let's look at the High School Science schedule for an example:

- October 2022: Test Objective Review Conference
- January 2024: Item Review Conference 1
- March 2024: Practice Test Item Review Conference
- July 2024: Item Review Conference 2
- August 2024: Practice Tests Available/Test Registration Begins
- Early 2025: Standard Setting

In this example, higher education representatives serve on committees in October 2022, January 2024, March 2024, and July 2024; however, the practice test is not available until August 2024. Higher education representatives will receive their vouchers following each committee meeting, but they won't be able to use their vouchers for that specific field until August 2024. (They can use vouchers for any other available practice test, such as High School Professional Knowledge and Skills, Integrated Science (Secondary), etc.)

#### <u>MTTC: Test Fee Reimbursement Grant Program</u>

Public Act 119 of 2023 Article 3, Section 1104 appropriated \$1,000,000 for grants to reimburse eligible applicants who take a required MTTC test for the first time during the 2023-24 academic year. Information about eligibility and other FAQ can be found on <u>MDE's website</u>. Candidates who tested on or after October 2, 2023 received notification to apply for the grant on January 30, 2024. The emails come from Pearson and are sent to the address used to register for the test(s). Applicants will need to complete an application for each test.

Sometimes emails don't get through to candidates. Candidates can check their account by logging into mttc.nesinc.com, selecting "My Account," then "Test Fee Reimbursement Grant Application." There, they can view and manage all eligible applications. Please send any questions to Bridgett McDowell at <u>McDowellB@Michigan.gov</u>.

#### • MTTC: Test Preparation

MDE recommends the following MTTC test preparation resources:

- <u>Study Materials</u> a how-to guide on identifying and using study materials that have been designed for MTTC test-takers
- Webinar a <u>recorded webinar</u> on the MTTC program; identifying and using appropriate study materials; interpreting your score report. <u>Annotated slides</u> used in the webinar are also available to view at your own pace.





MDE exclusively recommends materials that have been designed for teacher candidates, understanding that materials accessible outside the MTTC program (e.g., course notes or readings, PK-16 student texts or artifacts) are also valuable aids in preparing for an exam. *MDE does not recommend* "MTTC prep" materials that are marketed to candidates, such as Mometrix, 240 Tutoring, Study.com, Quizlet, or similar.

#### • School Librarian Preparation Standards

Public comment on the proposed <u>School Librarian Preparation Standards</u> closed on March 10. OEE is collaborating with representatives of the standards committee and colleagues in the Library of Michigan to review and respond to public comment. We are preparing to present summary and finalized version of the standards at the June SBE meeting for vote and approval.

#### • <u>Surveys</u>

The SS2024 Candidate Suite Surveys and Year Out Survey are in the field. Survey respondents have until Sunday, June 9 to complete the surveys. Reminders are programed to go out every two weeks. EPPs can review the respondents who have completed the surveys on the Qualtrics dashboard (https://mde.co1.qualtrics.com/vocalize). MDE encourages providers to reach out and

remind missing respondents to complete the survey by the deadline since the response rate is included in the performance score.

The Administrator Survey will be distributed on April 17 to the administrators with oversight responsibilities for first year teachers. The survey will close July 14.
