

Legislative Updates – FY '25 Budget

Passed Bills

 SB 518 – Extends the sunset on special education alternative route programs has been put into law as PA 49 of 2024. 6/11/2024

Active Bills (Moving)

 SB 567 & 568 – Dyslexia training for pre-service and in-service teachers. Passed Senate and House. Heading to governor for signature. 9/25/2024



Preparation

Dyslexia Legislation Requirements By September 30, 2027, **all** programs must offer instruction in:

- a) The characteristics of dyslexia and underlying factors that place pupils at risk for difficulties in learning to decode accurately and efficiently.
- b) The secondary consequences of dyslexia, such as problems in reading comprehension and a reduced reading experience that can impede the growth of vocabulary and background knowledge and that can lead to social, emotional, and behavioral difficulties.
- c) Instructional adjustments for pupils with dyslexia and instructional adjustments for addressing underlying factors that place pupils at risk for difficulties in learning to decode accurately and efficiently.
- d) Methods for developing schoolwide and classroom infrastructure that meet the collective and individual needs of pupils using a multi-tiered system of support (MTSS).



Dyslexia Legislation Requirements (cont'd) By September 30, 2027, programs that involve reading instruction, language arts, special education, or school psychologist licensure must offer instruction in:

- i. Evidence-based instructional methods and features of evidence-based interventions that are grounded in the science of reading and principles of structured literacy that are designed for pupils with characteristics of dyslexia and pupils at risk for difficulties in learning to decode accurately and efficiently.
- ii. Evidence-based instructional methods and features of evidence-based interventions that are grounded in the science of reading and principles of structured literacy that are designed to effectively meet the needs of most pupils.

Implementation Plan

EPPs will provide documentation to demonstrate compliance with dyslexia legislation along with program applications for Disciplinary Literacy Standards and a review of reading diagnostics coursework



Disciplinary Literacy Preparation Standards 5-9/7-12

- Disciplinary Literacy Preparation Standards (DLPS) for teachers of 5-9/7-12 replace the 2002 standards for reading coursework required by rule for secondary certifications.
- The adoption of these standards initiates EPP program review; timely juncture for review of literacy course of study across PK-12.
- DLPS application, guidelines, and implementation resources with recording of September 13 Webinar are being emailed to EPPs.



DLPS Application Process & Dyslexia SB568

- Implementation goal: an aligned system of teacher preparation in literacy across all endorsement areas, PK-12
- DLPS application process includes guidance for reviewing reading diagnostic coursework and SB 568 requirements for preparation of candidates in dyslexia.
- Completed Applications Due to MDE June 30, 2025



Reminder: Paired Endorsements

- English as a Second Language (NS) & Bilingual (YA-YT)
 - Elementary (Lower, Upper, or ZG), any endorsement within English Language Arts, Mathematics, Social Studies, or Science
 - May also pair with World Language
 - Bilingual and World Language (FA-FS) must have OPI in addition to MTTC
 - Consider opportunities to engage in clinical practice across PK-12
- Special Education
 - Any general education endorsement
 - Note different requirements for initial and additional



MTTC: Professional Knowledge & Skills

- Grade-banded PKS tests out now
 - MI117 (PK-3), MI121 (3-6), MI135 (5-9), MI136 (9-12)
 - ZO, ZP, BQ, EQ, (DQ, CQ)
- Every endorsement needs a PKS test beginning
 January 1, 2026
 - Ex: World Languages, Music, BMMT
- Initial certificate only
 - NOT additional on Standard+
 - NOT Administrator (ES, CO)
 - Notification to Dana Utterback necessary for additional endorsement applications





- Task 2: Once the MOECS profile is created, candidates need to link their MOECS profile to an EPP.

EPP Tasks:

- Task 1: Accept/reject enrollment of each candidate.
- Task 2: Periodically update candidate program and status within the program.

PROGRAMS FOR SCHOOL STAFF

GREAT NEWS for Section 27b GYO grant! All \$175 million awarded

- Includes federal and state funding sources
- Designated Round (Round 3)
 - Most recent and final round of funding
 - Notifications distributed 9/12/24
 - 70 districts total
 - Group 1: Districts with one or more schools indexed for support (SIS)
 - Group 2: Districts who were previous grantees

New EPP Agreements Ahead

- Compressed timeline: no extra time for grant activities per ARP fund rules (deadline 12/2026)
- Candidates may have started, or are waiting to start, preparation pathways
- New grantees may already have tuition expenses ready for reimbursement

- Same goals as last fiscal year




