
Treasurer's Report








Budget Season Highlights



- Governor's executive budget recommendation includes \$50 million for 27b Grow Your Own programs
- Senate School Aid budget bill
 - \$20 million for educator housing
 - Continued funding for MI Future Educator Fellowships & Stipends
- Neither Governor nor Senate continue funding for MTTC reimbursement grants





Active Bills



- HJR E Provides governor-appointed superintendent of public instruction, reported out of House committee, 3/19
- HJR G Eliminates State Board of Education
- HB 4148 Requires State Board of Education members to be selected from districts
- HB 4150 Eliminates certification fees passed House, 3/12
- HB 4151 Allows for additional endorsement by exam passed House, 3/12
- HB 4152 Requires math and science professors to develop teacher preparation programs in math and science reported out of House committee, 3/5
- HB 4153 Creates local teaching certificates, issued by school districts passed House, 3/12





- Closure forms & rosters due six months after date on approval letter
- Vital for public directory & ensuring teach-out candidates can get certified
- Helpful to include candidates who completed but didn't get certified





MTTC: PKS Tests – What if...



 A candidate finishes their additional endorsement program for ESL in May 2026?

This isn't a worry. PKS tests are only required for initial certification.

A Professional Knowledge and Skills test is required in the following scenarios:

Effective July 2022, candidates pursuing initial certification for Lower Elementary (PK-3)
 Education (ZO); Upper Elementary (3-6) Education (ZP); English Language Arts (5-9), (7-12),
 (BQ); Mathematics (5-9), (7-12), (EQ).



 Effective January 2026, candidates pursuing initial certification in any other endorsement, as documented in <u>Active Endorsements and MTTC Alignment guidance</u>.





MTTC: PKS Tests - What if...



 A candidate finishes their initial certification for Latin in December 2025?

Their EPP can advise them to apply in MOECS before 11:59pm on December 31, 2025 if they do not want to take a PKS test.

If they wait until after 11:59pm on December 31, 2025, MOECS will require a PKS test.






MTTC: PKS Tests – What if...



• I can't respond to applications in MOECS on December 31?

This is not a worry. The timestamp that matters is when the candidate applied in MOECS, not when an EPP responds to the application.








MTTC: PKS Tests – What if...



 A candidate applies in MOECS for initial certification in Bilingual-German just before the ball drops in Times Square?

MOECS will not look for a PKS test.








MTTC: PKS Tests – What if...



 The world has a Y2K moment and the application doesn't go through in MOECS until just after midnight on January 1?

The candidate applied on January 1, so MOECS will look for a PKS test.














MTTC: Social Studies (7-12)

Why (besides honorarium, SCECHs, practice test access, travel reimbursement, engaging professional development, etc.)

This was such a valuable process. I have had an intern for the past eight years. Each one has said they were frustrated with the test, and I have been accumulating reasons why they were frustrated over the years. This committee addressed all those concerns. I feel much more confident that teacher candidates taking this test in the future will have a much more accurate and useful assessment of what they should know to be a successful teacher. Thanks for helping me grow as a professional.








What to avoid

- Many "MTTC" materials marketed to candidates
- Examples: Mometrix, Study.com, 240 Tutoring, Passage Preparation, Learning Liaisons

Why you should avoid it

- Poor alignment to grade range
- Low-level questions
- Poor alignment to test objectives





MTTC: Reimbursement Grant – What if funds run out?



- MDE will communicate to field (listserv, MDE website, MTTC website, etc.)
- If we're confident the program will be included in the FY26 budget, recommend EPPs advise candidates to reschedule appointments for October 1, 2025 or later.
- If we're not confident the program will be included in the FY26 budget, recommend EPPs advise candidates to continue to test as appropriate, understanding that funds may run out before they can apply, despite being otherwise eligible.
- MDE will continue to update the field.


Once funds are exhausted, MDE will update communications to the field.



MTTC: Administrator Testing



- Phase 1 for administrator testing will continue through 2025
 - Good faith effort
 - Not required for ES or CO endorsement
- Phase 2: TBD 2026
 - Passing test (scaled score 220 or more) required for ES or CO endorsement
 - Phase 2 start date to be determined (2026)
- Vouchers are now expired
 - First time test takers qualify for Test Fee Reimbursement Grant






Student Loan Repayment Program






- Dual-focus grant






Mentoring and Induction



- Mentoring and Induction Standards are reaching the final round of revisions.
- American Institutes for Research (AIR) has initiated the collection of baseline data for the Evaluation Grant.
- District Support Grant closed on March 27th. We received a lot of interest from districts. Given the large number of applicants, we will still need more reviewers.



Data Dashboard




- Updated with 2023-24 data
- Trends & Nuances
 - Year-over-year increase in number of initial teaching certs
 - 21% increase compared to 2022-23
 - Growth primarily due to temporary credentials (ITC)



- Interactive filters added, including EPP-level details in survey reports
- Visual displays (live map of regions, school districts)








Surveys & Candidate Tracking

 - March 19 to June 15






Completer Definition



Updating ES definition of a completer to match Title II glossary:

"Code 3 - Program Completer: A person who has met all the requirements of a state-approved teacher preparation program. Program completers include all those who are documented as having met such requirements. Documentation may take the form of a degree, institutional certificate, program credential, transcript or other written proof of having met the program's requirements. In applying this definition, the fact that an individual has or has not been recommended to the state for an initial teaching credential may not be used as a criterion for determining who is a program completer."


